Alberta Fish and Wildlife Management Update

June 10, 2023

Fish and Wildlife Stewardship Branch (FWSB) and the Hunting and Fishing Branch (HFB) Aquatic Invasive Species (AIS)

- Last year Alberta operated 5 watercraft inspection stations:
 - A total of 8032 watercraft were inspected by staff.
 - 5206 of these watercraft were deemed high risk due to their point of origin.
 - Inspectors intercepted 19 mussel-fouled boats
- This year again, Alberta is again operating 5 watercraft inspection stations: Cold Lake, Vermilion, Medicine Hat, Coutts, and Carway. These locations are selected to prevent the highest risk of invasive mussels entering Alberta from the east and south.
- The program is expanding monitoring capacity through a collaborative research project with the University
 of Alberta using eDNA techniques to detect presence of AIS in Alberta waterways. The project is targeting
 twelve invasive species including, plants, crayfish, fish/fish disease, and invertebrates.
- Flowering Rush Lake Isle: The program is currently in year two of the five-year herbicide response effort. It is the largest scale flowering rush response project in Canada (eight years of engagement and consultation before implementation).
- Prussian Carp: FWSB is assessing netting efforts from the Blood Indian Reservoir to determine feasibility and success as a management option. There are also new detections in the North Saskatchewan watershed, FWSB is evaluating response options.
- FWSB is developing a plan to address the ongoing expansion of Prussian Carp in the province The plan will guide and describe the decision-making approach for appropriate management actions.
- Goldfish: Goldfish occurrences continue to increase in stormwater management ponds. Response at these locations continues to be a priority.
 - We appreciate our partners embracing and sharing our "Clean, Drain, Dry Your Gear and Don't Let It Loose" campaigns (Kevin did the clean drain dry re: whirling disease the other night)
- Purple Loosestrife: FWSB is continuing a collaborative project with the Municipal District of Wainwright to
 use herbicide control in Engstrom pond, south of Wainwright, to prevent purple loosestrife being transferred
 to the Battle River, where response would be exponentially more difficult.

Wildlife Disease

Developing an ongoing program to mitigate risk to bighorn sheep from infectious bacterial pneumonia (M. ovi), with immediate focus on the Sheep River area.

Landuse/Habitat

 Watercourse Crossing management: FWSB is working with Water Policy to update the Watercourse Crossing Code of Practice, and with AB Transportation and other partners to refine watercourse crossing remediation planning.

Fisheries Updates

- HFB supported the ACA kids can catch event again this year with a licence for participants to harvest up to 50 walleye at Wabamun Lake.
- HFB and FWSB are expanded the walleye stocking program to the north this year with two wild gamete takes. Goose, Minnow, Winagami and Crane lakes were stocked with fry this year.
- HFB increased the purchase allowance of SHL licences for walleye from 2 to 5 this year

- This year we are already seeing that the high air temperatures combined with lower-than-expected snowfall in 2023 have resulted in depletion of all measured snow pillows in southern Alberta mountains.
- Streams in southwest Alberta are already experiencing extremely low, and often warm flows. This is approximately one month earlier than would occur in an average year.
- It is expected this will result in decreasing flow conditions and rising water temperature conditions which will
 result in conditions that pose threats to fish and fish populations.
- Both branches are working together to assess the conditions in consideration of application of time of day restrictions (ToD).
- The emerging concern beyond ToD, is the extremely low flows that are occurring across ES1 and ES2.
 FWSB South Region is looking into this further and how we may respond.

Licensing

Updated information from the HFB on hunting and fishing sales metrics:

The Special Licence application period is for the first week of the application period (May 30 – June 4). The remaining licence types are a comparison of March 15 – June 4). March 15th is when HFB starts the new licence year sales so it is good comparison of licence sales over the same time period (2022 vs 2023).
