 just do not have the resources to take it on ourselves.
- Fish stocking will be reduced due to ever increasing costs of close to 50% over the past 5 years.
 ACA is looking into putting perch into those ponds that we already know that the trout we are stocking are not surviving.
- Pheasant Release Program Hoping to sign a contract with our Alberta producer to supply 10,000 birds, having no more than six producers would be ideal. Ultimately, our goal is to be able to release healthy birds that can fly.
- Food Water Wellness Project Auditor General's people came to audit the project, Lori-Jeanne accompanied them to a pig farm.
- ACA has moved the Cochrane office to a new location.
